Client shall be responsible for ensuring that the following agreement terms and conditions are met.

Agreement to participate in TRAK Horseback Riding Lessons has the initial start date of _____, and ending date of _____ during _____ session(s). The client, with whom HRL agreement has been initiated, has understood and acknowledged the service charges in the amount of \$_____ per lesson on the day of the lesson, or in advance. TRAK reserves the right to adjust monthly fees and services, or to cease at any time to provide horseback riding lessons as a service.

The client agrees to pay the amount identified above for the full term of the HRL agreement, including any renewal term. If client needs to change any of the agreement terms and conditions, the client must provide written or verbal notice to TRAK at least 48 hours prior to the next lesson date. No additional fee will be charged for changes to agreement if given proper notice.

This agreement may be canceled at any time by client upon thirty days written notice to TRAK, which shall be hand delivered or deposited in the US mail with adequate postage to TRAK business address. If client cancels for any reason whether before or after TRAK has rendered services, TRAK shall be entitled to retain payment for days of services rendered, if any. If cancellation is made *without advance notice*, your reserved riding time will be offered to another student and your card on file will be charged until the slot is filled by another rider for the term of the agreement.

If for any reason the cancellation of this agreement results in monies due to TRAK, such monies shall be paid in full within 30 days of cancellation. Failure to make payment may lead to taking responsibility for collection costs, whether or not a legal action is commenced. In the event of any legal proceeding (including appeals), the

prevailing party shall be entitled to recover its costs, disbursements and reasonable attorneys' fees as determined by the court. ***Any pre-paid lessons or sessions not used within one year from the original purchase date will be forfeited and monies will be converted to donations to TRAK programs.***

If TRAK has an issue with charging your card, i.e. your card has expired, you will have 7 days to get TRAK your payment and update your card information with our finance department. You will be notified if TRAK has an issue. Lessons not paid within 7 days of the lesson date shall incur a late charge of \$25.00 per lesson on top of the due amount.

Client shall fill out and sign the authorization for payment in this agreement.

In agreement to the horseback riding lessons at TRAK, client shall be responsible for updating current financial payment method and authorization details, hereby permitting TRAK to bill and receive payment for all fees associated with the HRL agreement. Lessons can be paid either by cash, check, credit/debit card, or Automatic Clearing House (ACH) transfer. Please keep in mind that an overdraft and reprocessing fee of \$25.00 will be billed to client on returned/dishonored charges from client's bank accounts. Please let us know of any questions or concerns on our terms and conditions.
